 - Healthcare for Homeless Veterans (HCHV)
 - The central goal of HCHV programs is to reduce homelessness among Veterans by engaging and connecting homeless veterans with healthcare and other needed services.
 - Target chronically homeless Veterans, especially those with serious mental health diagnoses and/or substance use disorders. Provide outreach, case management and community based residential services to ensure that Veterans have access to programs that provide quality



housing and services that meet the needs of these special populations.

- Services include HCHV case management; HCHV outreach services; HUD VASH; HCHV Contract Residential Services and Coordinated Entry Initiative.
- Work with Coordinated Entry System, HARA, SSVF Prevention.

- VA follows Housing First model.

 - Benchmarks:
 - Chronic homelessness among veterans has been ended
 - Veterans have quick access to permanent housing
 - The community has sufficient permanent housing capacity
 - The community is committed to housing and providing service-intensive transitional housing to veterans experiencing homelessness only in limited instances

 - Total Disposition Referrals in 2022: 239 (177 active).
 - 46 chronic, 49 non-chronic 12+ months, 144 other.
 - HMIS Breakdown in 2022:
 - 14 in Permanent Supportive Housing, 22 in Rapid Re-Housing.
 - Shelter List Breakdown in 2022: 126 total referrals (94 active).
 - 23 housed, 20 deactivated.
 - Veteran BNL Breakdown in 2022: 36 total referrals (15 active).

Description: The webinar will provide information about Criminal Sexual Conduct (CSC) convictions in Michigan. Attendees will learn types of offenses, Sex Offender Registry requirements, and common barriers faced by people with CSC convictions. Attendees will also hear about housing provided for people on parole funded by Michigan Department of Corrections through its Offender Success (OS) program. People in OSfunded housing with CSC convictions face additional barriers to reentry. The information will benefit anyone who provides housing services to people who may have a CSC conviction, as well as anyone with an interest in learning more about the topic.
