 - Transitional program to help the community after CERA.
 - Provides **in-depth** case management to help clients reach housing stability.
 - Screenings and referrals for other programs.
 - Connection to Legal Services.
 - Assistance applying for SER, Food Assistance.
 - Helping create emergency budgets and long-term stability budgets.



- Finding alternative housing situations (affordable, temporary/long-term).
- Continues until the household is stably housed.
- No financial assistance currently.
- HSS General Eligibility:
 - Under 80% Area Median Income (AMI)
 - Resident of Oakland County
 - Renter Households
 - Housing Instability
 - Court Involvement (Demand for Possession / Notice to Quit, Summons, Judgment, etc.)
 - Doubled Up
 - Fleeing Domestic Violence & Human Trafficking
 - At Risk of Homelessness
 - Literally Homeless
 - Homeless Preference HCV holders
- Moderate risk households based on CoC Prioritization Thresholds
 Homeless Prevention:
 - Case management and short-term rental assistance to prevent homelessness
 - Eligibility:
 - HUD Cat 2 Definition and/or At Imminent Risk
 - Below 30% AMI (some below 50% AMI)
 - Additional Info:
 - Unit Inspections
 - FMR and Rent Reasonable requirements
 - Require landlord participation
 - 1-6 months of arrears depending on the program
 - Very High-Risk Households based on CoC Prioritization Thresholds
- HSS and HP Prioritization Criteria:
 - Prioritization ensures we serve those with the highest risk factors first. Everyone who is eligible is added to the appropriate registry.
 - Some criteria include:
 - Large households (5+)
 - Individuals with disabilities
 - Seniors
 - Previous evictions
 - Households impacted by:
 - Domestic Violence
 - Human Trafficking
 - Foster Care / Child Protective Services
 - Justice system involvement
 - Previous CERA clients (for Stability Services only)
- Coordinated Entry Process:
 - Complete Assessment: HRC: 248-269-1335; Webforms on Lighthouse & CHN websites.
 - Agencies Interpret Results: Provide resources during call or via email afterwards.



- Referred to Registry if appropriate: Eviction Prevention or Housing Stability Services.

- Centralized Housing Registry Policy Updates
 - Group reviewed the policy changes.
 - Threshold is 9.
 - Participants are assigned to one program at a time.
 - Veterans will be pulled for VASH or SSVF unless ineligible.
 - Prioritization Criteria:
 - 1. Chronic
 - 2. Homeless Start date
 - 3. Unsheltered/Sheltered
 - 4. VI
 - 5. Referral Date
 - Communication Attempts Policy.
- PIT Count
 - Point in Time count of sheltered and unsheltered individuals will take place on Wednesday, January 25, 2023, 7pm-11pm.
 - 6 teams more needed.
 - 2 deployment sites identified: Lighthouse in Pontiac and Royal Oak City Hall.
 - Rapid COVID test kits needed.
 - Volunteers are needed to canvas Oakland County.

- Chronic Numbers & Veteran Numbers presented by Holly Gauthier.
 - Year End 2022:
 - Total Disposition Referrals in 2022: 494 (206 active).
 - 46 chronic, 23 non-chronic 12+ months, 137 other.
 - HMIS Breakdown in 2022:
 - 40 in Permanent Supportive Housing, 198 in Rapid Re-Housing, 11 HCV, and 64 Other - Self Resolved.
 - Shelter List Breakdown in 2022: 126 total referrals (8 active).
 - 79 housed, 113 deactivated.
 - We have stopped taking shelter referrals and currently working on winding down the shelter list.
 - Veteran BNL Breakdown in 2022: 44 total referrals (13 active).
 - 20 housed, 16 deactivated.
