New Business

- Coordinated Entry App
 - Beginning phase in conversation with community partners, shelters, funders, and looking to bring additional partners into the conversation.
 - Web-based focusing on:
 - Coordinated entry
 - Connecting literally homeless folks to housing resources
 - Prevention
 - Shelter bed availability/booking
 - Additional services to include: behavioral health resources, food resources.
 - Organizations will be updating funding/resource availability regularly on the app.
 - Targeting launch in a year.
- Eviction Prevention Funding
 - Will be receiving Oakland County CDBG CV funds for eviction prevention tied to CERA/HSS staff (CHN & Lighthouse) for those eligible with COVID hardship.
 - Receiving MSHDA funding HPP.
 - Each funding source has different eligibility requirements.
- HARA is taking live calls
 - For screenings, call: 248-269-1335
- Landlord Event Topics
 - Looking to engage new landlords to invite to an event (virtual, in-person, or hybrid).
 - Event to educate about helping programs in the community, barriers to participation, speakers, sharing success stories, and other topics.



Committee and Workgroup Reports

- Alliance Committee Summary Reports – Group reviewed.
- Chronic Numbers & Veteran Numbers presented by Holly Gauthier.
 - January 1 - February 22, 2023:
 - Total Disposition Referrals: 90 (178 active).
 - 24 chronic, 10 non-chronic 12+ months, 56 other.
 - HMIS Breakdown:
 - 16 in Permanent Supportive Housing, 19 in Rapid Re-Housing, 0 HCV, and 23 Other - Self Resolved.
 - Shelter List Breakdown:
 - Due to the end of COVID funding the Shelter Registry is being worked through and no further referrals will be added to the list.
 - We currently have 4 people on the Shelter Registry and they have been working with Case Managers to obtain housing.
 - Veteran BNL Breakdown: 5 total referrals (12 active).
 - 4 housed, 2 deactivated.
