The above named agencies will work together, as part of the Continuum of Care (CoC) and the network of housing/homeless service providers, to coordinate services for individuals and households in need of housing related assistance. This agreement will allow for the CoC to locate program participants to link with services, verify occasions of homelessness for third party verification, and refer to additional community resources and programs, and other scenarios to assist the program participant in resolving their housing crisis.



This document is valid for 2 years, 2024-2026

The purpose of this agreement is to coordinate services.

Furthermore, the participating agencies

- Acknowledge that in transmitting, receiving, storing, processing or otherwise dealing with any consumer protected information, they are fully bound by state and federal regulations governing confidentiality of patient records, including the Federal Law of Confidentiality for Alcohol and Drug Abuse Patients, (42 CFR, Part 2) and the Health Insurance Portability and Accountability Act of 1996 ('HIPAA', 45 CFR, Parts 160 & 164), and cannot use or disclose the information except as permitted or required by this agreement or by law.
- 2. Acknowledge that they are prohibited from making any further disclosure of this information unless further disclosure is expressly permitted by the written consent of the person to whom it pertains or as otherwise permitted by state and federal regulations governing confidentiality of patient records, including the Federal Law of Confidentiality for Alcohol and Drug Abuse Patients, (42 CFR, Part 2) and the Health Insurance Portability and Accountability Act of 1996 ('HIPAA', 45 CFR, Parts 160 & 164), A general authorization for the release of information is **NOT** sufficient for this purpose.
- 3. Agree to use appropriate safeguards to prevent the unauthorized use or disclosure of the protected information.
- 4. Agree to notify each of the other participating agencies of their intent to terminate their participation in this agreement.
