New Business

- Point in Time count (PIT)
 - PIT is a HUD mandated annual event to count and survey people experiencing homelessness (both in shelters and on the street) on a single night in January. This helps to assess scope of homelessness and allocate resources.
 - Volunteers will be needed on PIT night to help canvas all of Oakland County.

- Web-Based App Update



- We are working with Reciprocity to develop a web-based app to coordinate and connect people to services using technology. Goals of the app include coordinated information gathering, screening for eligibility, and real-time shelter availability.
- We are currently in phase 1 of fact finding which includes meeting with agencies/community partners and people with lived experience to gather input.

- EHV Report Out by Taylor Eberhart, CHN
 - Emergency Housing Voucher (EHV) was a program started during the pandemic with expanded eligibility and supportive services.
 - CHN & Lighthouse worked as service providers and Oakland County received 56 vouchers from MSHDA and additional from DHC.
 - The EHV waitlist closed in November 2021 with over 200 people still on the waitlist.
 - 239 households were pulled from the waitlist; over 400 people served.

- Homeless Verification Letters
 - Homeless verification is needed for individuals to access many programs.
 - Third party agency/entity needs to provide verification based on their observations.
 - Third Party Homeless Verification form template and example will be sent out with meeting minutes.
 - Discussion around who can complete the Homeless Verification in Oakland County and if it should only be those that have signed the Coordinated Services Agreement.
 - The Coordinated Services Agreement MOU is to share information related to housing among partners and be listed on released of information (ROI) for all partners on the agreement.
 - To become a sharing partner on the <u>Coordinated Services</u>
 <u>Agreement</u>, contact <u>Julia Steinberg</u> to sign the MOU.

- The group identified grey areas and provided feedback; a vote may be held at a later date.

Committee and Workgroup Reports

- Alliance Committee Summary Reports Group reviewed.
 - Taylor suggested the creation of a diversion/prevention committee or workgroup to include non-financial prevention tools.
- Chronic Numbers & Veteran Numbers Report Update presented by Holly Gauthier
 - Within HMIS, HUD is doing data standard updates which has caused issues with the vendor and prevented the ability to pull reports at this time. A year-end report is expected to be available at the next GM meeting in January.
- Veteran Updates Presented by Monisha Scott
 - New calendar year has 3 new housing goals:
 - Permanently house at least 38,000 Veterans
 - Currently at 96% of goal for calendar year.
 - Prevention of returns to homelessness
 - Goal achieved of less than 5% returning to homelessness and over 90% of which are rehoused or on a path to rehousing.
 - Increase outreach to engage with unsheltered Veterans
 - Goal has been met.
