## **Committee and Workgroup Reports**

- Alliance Committee Summary Reports Group reviewed.
  - Please contact <u>Leah McCall</u> if you have questions or are interested in joining a committee.
- Chronic Numbers & Veteran Numbers presented by Holly Gauthier.
  - January 1, 2021 through August 26, 2021:
    - Total Disposition Referrals in 2021: 387 (170 active).
      - 77 chronic, 54 non-chronic 12+ months, 256 other.
    - HMIS Breakdown in 2021: 202 total housed.
      - 25 in Permanent Supportive Housing, 177 in Rapid Re-Housing.
    - Shelter List Breakdown in 2021: 110 total referrals (52 active).
      - 21 housed, 39 deactivated.
    - Veteran BNL Breakdown in 2021: 32 total referrals (10 active).
      - 7 housed, 15 deactivated.
- Veteran Updates (SSVF and BNL) presented by China Aquino.
  - VA gave every SSVF grantee additional funds for shallow subsidies, effective as of November 1<sup>st</sup>.



- SSVF will pay 30-50% of rent for veterans (referred through RRH or prevention) for guaranteed 2 year duration to encourage individuals to gain work experience, training, and job security and increase income.
- VA is asking all SSVF providers to provide legal services.
- China's last day with OLHSA will be November 10.
