**Snapshot of OC current situation- Angela Gougherty, OC HMIs & David Permaloff, Common Ground** Annual homeless numbers: approximately 4,115 homeless people served in 2017, 312 of whom were identified as chronically homeless and 170 of whom were identified as veterans

PIT and HIC 2018 -- 427 homeless people on the night of the 2018 PIT; 2018 HIC demonstrates 1% OPH, 20% ES, 7% TH, 30% RRH, 42% PSH
