The Notice of Funding Opportunity (NOFO) for FY2024 - 2025 funding portion of the FY2024 - 2025 Continuum of Care (CoC) Program competition has been released. The Alliance for Housing of Oakland County is the HUD-approved Collaborative Applicant for the FY2024 - 2025 Continuum of Care Application. In this role, the Alliance for Housing is responsible for leading and managing the decision-making and application process for the FY2024 - 2025 HUD Continuum of Care Homeless Assistance Funding application for projects seeking both renewal and new HUD funding.
